

## **EDGF Open Positions – Call for Candidates**

## 1. Call for the position of Board of Directors

The EDGF Board of Directors has seven (7) members. It consists of:

- the chair-person (president)
- the vice-president
- the general secretary
- the treasurer
- board members

Currently, the general secretary holds the position of the treasurer too.

BoD members have the following responsibilities:

- holding a position (if available and willing)
- attending the meetings (online) regularly once a month
- joining in with board discussions and offering their ideas or opinions
- voting on board matters
- making motions

EDGF is looking for two (2) additional volunteers interested in advancement of the organized disc golf in Europe, particularly those identified with the general vision of EDGF as the organization representing national disc golf governing bodies in individual European countries.

## 2. Call for the position of Auditor for the EDGF

The EDGF so far creates income via sanctioning fees from the hosts of the respective ECs (Open/Junior/Masters). From 2024 on there will be additional income from annual membership fees. The money is administrated and spend by the board of the EDGF.

The EDGF is looking for two (2) Auditors who are able and willing to check the way the finances got managed over the last business year and testate about his findings to the General Assembly who will disburden the board based on this report.

- The auditor should be able to understand and handle basic financial operations.
- The job has to be achieved in the weeks before the regular general assembly (November/December).



- The job can be done from home.
- The general secretary or future treasurer, who also will assist the Auditor in all possible ways, will provide all necessary data in time.
- The time exposure for this work will be approx. 2-3 hours a year for the testing and about 1 hour a year to reporting to the general assembly.

## 3. Call for the position of a representative of the EDGF in the cooperation/relationship with the EFDF and WFDF

The EDGF sends one representative to the board of the EFDF.

This representative is predominantly responsible for all aspects of the EFDF work that might have an influence on Disc Golf in general and on the work of the EDGF in particular. The representative is furthermore equal member of the board on takes part in all discussions and decisions of the board of the EFDF.

- The representative will be also responsible for the upcoming relationship/cooperation with the WFDF.
- The board of the EFDF is highly capable and motivated.
- The representative should be interest in the international aspects of Disc Golf, the development of new relationships, respective the nurturing of already pre-set relationships/cooperation.
- The representative should be motivated to get involved in all aspects of flying disc sports.
- The board of the EFDF has regular meetings once a month. Sometimes additional information is exchanged via email.

The representative would work in close cooperation and exchange with the board of the EDGF. He or she will take part in those board meetings/parts of board meetings that pertain to his field of work.
